But the president of the United Workers of Quebec (UQ) argues it's not entitled to the fees because the city's pursuit of the claim violated the union's charter and the city didn't prevail in court. The case began in late 2014 when the city suspended the former UQ member because of "grievances and insubordination." The union fought his dismissal in court, arguing the city should compensate him for the four years he spent on the job. The city responded that the employee's contract had been set to end on Feb. 1, 2014, and it couldn't force him to work another day. The court sided with the city. In its ruling, the Superior Court of Quebec found the former employee had been on paid administrative leave before the official contract expired and the dismissal would have occurred whether or not he was still employed by the city. Story continues below advertisement The court determined, in a nutshell, the union hadn't shown it was its fault for getting the former employee in a bind. The decision prompted the city to file an application for legal costs. "On the basis of the available information," it said in its decision, it's likely the worker was able to work elsewhere in the interim. "This time frame is, however, extremely short. During this time, [the former employee] could have been included in the Civil Service Pension plan. In this case, the applicant would have been obligated to pay a portion of these costs since it is not without fault. In an analogous situation, the applicant would have been entitled to remuneration."
