In the instant case, the IRS's interest in the annuity was potentially worth about \$2,100 in mid-March, 1986. Defendants argue that the interest on that sum was a sum certain and the penalty claimed for failure to pay it within 10 days was therefore not in the nature of a demand for payment under UCC § 4-213. However, if the annuity were being "held by the creditor" at a rate of return, there would still be a claim against the annuity for the unpaid interest. Plaintiff bears the burden of proof as to the value of the annuity. *Starnes v. National Bank of Middleton*, 103 Idaho 747, 748-749, 654 P.2d 1336, 1337-1338 (Ct.App. 1982). Hence plaintiff is not attempting to enforce a right to payment that was certain. It is attempting to collect a claim which was speculative in value. Accordingly, § 4-213 does not control.
