[8] Tennessee Code Annotated section 33-6-102(a) and (b) provides in pertinent part: (a) As used in this chapter, unless the context clearly requires otherwise, "voluntary admissions" means any admission of a patient, made voluntarily and without restraints by the patient or by another person who does not have actual or apparent authority to make such an admission, to a hospital or other institution having facilities or personnel available for the voluntary admission of patients, when: (1) A physician has determined that the patient lacks the capacity to make a reasoned decision with regard to the admission...; .... (b) Any admission of a patient, made voluntarily and without restraints by the patient or by another person who does not have actual or apparent authority to make such an admission, may be obtained by a law enforcement official.
